3. How We Collect Personal Information

We may collect information:

- Directly from you (e.g. via donation forms, registrations, emails, calls)
- Through your use of our website and services
- From publicly available sources
- From partner organisations when you use joint services (e.g. UrMeals partners, local charities, crowdfunding platforms)

We use cookies and similar technologies to understand website traffic and improve your experience. You can manage cookies in your browser settings.

4. Why We Collect Your Information

We only collect personal information reasonably necessary to carry out our charitable purposes, including:

- Processing and confirming donations
- Issuing donation receipts (including for tax-deductibility)
- Providing and improving our services (e.g. meal delivery coordination)
- Managing user accounts and registrations
- Communicating with you about our programs, projects, and campaigns
- Enabling crowdfunding projects
- Conducting research and advocacy
- Meeting our legal obligations (including regulatory reporting)

5. How We Use and Share Your Information

We may use and share your personal information:

- Internally, to provide you with our services and support our mission
- With trusted service providers (e.g. payment processors, IT providers) under confidentiality agreements
- With partner charities for program delivery (e.g. meal distribution)
- With crowdfunding project owners you choose to support

 When required or authorised by law (e.g. for regulatory reporting or fraud prevention)

We will never sell your personal information.

6. Security of Your Information

We take reasonable steps to protect your personal information from misuse, interference, loss, unauthorised access, modification, or disclosure.

We use secure systems and processes (e.g. encryption, access controls). However, no method of transmission over the internet is 100% secure. We encourage you to protect your own login details and use secure networks.
